- **Level32 (USD190/bbl and more - less than USD195/bbl)**, the surcharge will be revised to **¥226 ¥193 and ¥161.**
- **Level31 (USD185/bbl and more - less than USD190/bbl)**, the surcharge will be revised to **¥219 ¥187 and ¥156.**
- **Level30 (USD180/bbl and more - less than USD185/bbl)**, the surcharge will be revised to **¥212 ¥181 and ¥151.**
