Regarding Additional Items of US Bound Shipments under ACAS **(Advance Information)**

Regarding the ACAS (Air Cargo Advance Screening) program that is already in effect for shipments to the US, please be noted there was a notice from U.S. authorities on additional required items in last summer.

After the effective date, there is a possibility that your cargo to be offloaded from the scheduled flight or penalty may be imposed by U.S. authorities.

In order to avoid those cases, we would like to request our customers to prepare the necessary arrangements for submitting the additional data elements. We appreciate your understanding and cooperation.
